

APPLICATION TO REGISTER A HORSE LIFE REGISTRATION OF SHOW &/ OR WORKING HUNTER

The Registration/ Classification Process:

The process for applying for Life Registration of a Show &/or Working Hunter Horse with the AHHA is as follows:

1. Find a Classification Day in your state

Before registering your horse, s/he must first pass Classification with the AHHA.

Details of upcoming Classification Days in your area can be found on the AHHA website:
www.hunterhorses.com.au or by emailing: jensw@bigpond.com

NB: RSVP is strictly necessary for all Classification Days

2. Attend an AHHA Classification Day

Full details of what to expect at AHHA Classification Days and the criteria that your horse will be assessed against is contained in the document called 'Classification' which can be found on the AHHA website: www.hunterhorses.com.au or by emailing: jensw@bigpond.com.

In summary, your horse will be assessed both in hand and under saddle by a panel of three AHHA Classifiers. The Classification process usually takes between 15 and 30 minutes per horse and horses may be assessed in groups.

You will be required to pay a 'Classification Fee' of \$11.00 to have your horse Classified.

If your horse passes Classification as a hunter, the last page of your Registration Application will be signed by all three AHHA Classifiers.

3. Complete the AHHA Registration Forms

Once you have completed your Registration Application Forms, including a signed Classification Section, please post them to

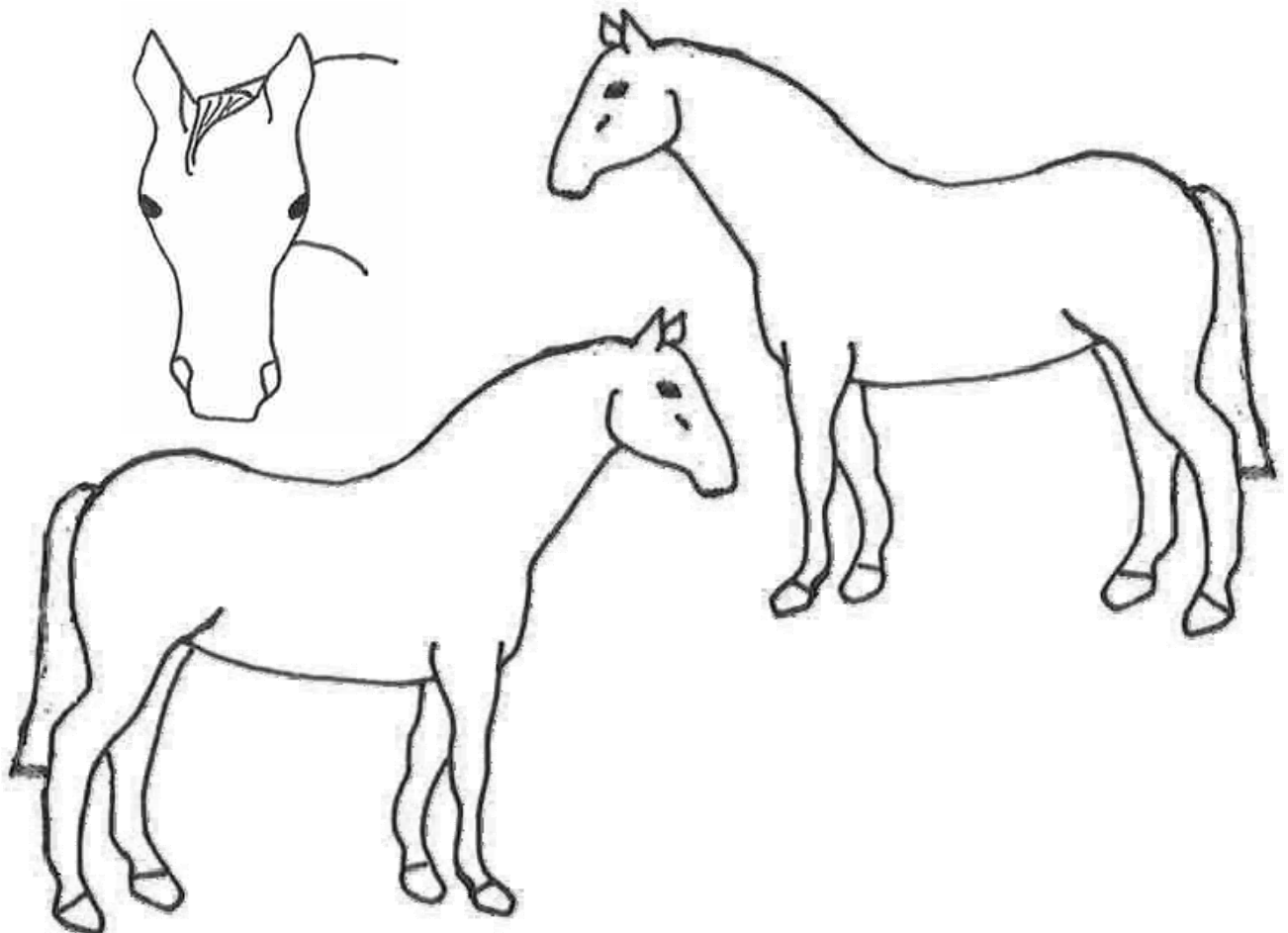
